Reading Techniques

The view finder projects an aiming beam that should be centered over the bar code, but it can be positioned in any direction for a good r. Hold the scanner over the bar code, press the button, and center t aiming beam on the bar code.



The aiming beam is smaller when the scanner is closer to the code, larger when it is farther from the code. Hold the scanner close to bar codes, and farther away from large bar codes to get a proper. If the bar code is highly reflective (e.g., laminated), you may need to hold the scanner at an angle so the bar code can be scanned.
